- Vote on Bylaw Changes
- *Old bylaws: The officers of the PTQB Club will consist of a President, (2)Vice Presidents, Treasurer, Secretary, Communications Director and a Social Media Communications Director . These named officers shall comprise the PTQB Club Board of Directors.*

**Proposed change: 7. Terms of office shall be for two years. A three-year term can be taken, if the majority (5/7 board members) are done with their service period at the same time. This need allows for people (s) to stay on the board for consistency, to not have the entire board transfer over at one time.
